HSMO rescues dogs from alleged mill

The Humane Society of Missouri rescued some 106 dogs from puppy mills in Missouri, including one kennel in Harrison County, according to a news release from HSMO.

HSMO's Animal Cruelty Task Force, along with the Missouri Department of Agriculture, rescued 38 neglected dogs from an unlicensed breeder in Harrison County. Other raids were held in Perry, Pettis and Ripley counties.

The humane society did not identify where the raid occurred in Harrison County. The sheriff's department or conservation department did not have any information about the rescue opera-

The dogs were taken to HSMO headquarters in St. Louis at the request of the National Mill Dog Rescue. The release said the dogs were receiving emergency veterinary treatment and health evaluations.

"The heroic efforts of our Animal Cruelty Taskforce were necessary to ensure the safety and wellbeing of so many helpless animals," said HSMO President Kathy Warnick.

HSMO said it had rescued many breeds of dogs, including Labrador retrievers, Boston terriers, poodle mixes, Cairn terriers and Yorkies.

The rescued dogs will be put up for adoption as they recover physically and behaviorally, HSMO said.

City to make improvements at dog pound

The Bethany City Council approved placing an advertisement to hire a caretaker for the city's dog pound as well as other measures to improve conditions at the kennel during its meeting last week at City Hall.

The city has faced criticism about the quality of care for the strays that are kept at the dog pound and about the small size of the holding pens. Roxanne Hoover, who works for an Iowa dog rescue organization, attended the city council session with several other volunteers. She said the "pet situation has gotten a lot better" in Bethany since she began coming here but there is much room for improvement.

Hoover, who works with the local volunteers, said problems at the dog pound include a lack of hot water to clean the pens.

"I would like to see an exercise area for the dogs," said Kristi Cox who attended the meeting along with other

She said Rose Hunt and Larry Hunt have been providing care for the dogs, but it's difficult to keep the facility clean because of the small size of the pens and the lack of hot water.

City Administrator Jake Taylor said the kennel was built to the standards set by the Missouri Department of Agriculture and has always gotten approval during regular inspections by the agency.

After discussing options, the council voted to employ a caretaker to oversee

County man sentenced in shooting

Avery William Cook, 21, of Eagleville, was sentenced Oct. 19 to 12 years in prison for wounding a man with a firearm in an incident that occurred last March on a road near Ridge-

Cook pleaded guilty to an amended charge of first degree assault during an

appearance before Circuit Judge Steven Hudson in Harrison County Circuit Court.

Cook was accused of shooting a passenger in his pickup, identified Cook as Jason Perkins Jr.,



five times with a 9-milimeter pistol while Cook was stopped on a roadway. According to the sheriff's department report, Perkins suffered gunshot wounds on the left side of the head near his temple, wounds to the arms and center of his chest. He was treated at Liberty Hospital.

Officers said Cook had stopped the pickup and asked Perkins to help collect money that was blowing away from the truck before shooting him. Perkins managed to get away despite his injuries. Cook fled from the scene and was taken into custody in Eaglevlle.

Prior to last week's court hearing, Harrison County Prosecutor Alex Van Zandt dismissed charges of assault in the first degree involving a serious physical injury and unlawful use of a

After accepting Cook's guilty plea, Judge Hudson ordered Cook to begin serving his prison sentence on October 20. He was given credit for 225 days he had been in custody.

Heather N. Young, Eagleville, will stand trial on May 28-31 for abuse or neglecting a child leading to death.

Justin David Smith, St. Joseph, was sentenced to five years in the Department of Corrections after pleading guilty to theft. Smith was arrested for stealing a pickup truck and firearms from a residence near Martinsville last December.

79 Years Ago October 18, 1944

On the farm, it's amber waves of graying hair

On Oct. 12, National Farmers' Day, Americans honored the hardworking people who keep the world fed and clothed.

But the farming labor force has a problem: It's aging rapidly.

The average American farmer is 57 and a half years old, according to the most recent data from the U.S. Department of Agriculture. That's up sharply from 1978, when the figure was just a smidge over 50.

As researchers who study well-being in rural areas, we wanted to understand this trend and its implications. So we dug into the data

Amber waves of graying

We found that the average age of farmers was fairly consistent across the country, even though the general population's age varies quite a bit from place to place.

For example, the average Maine farmer is just a few months older than the average farmer in Utah, even though the average Maine resident is more than a decade older than the average Utahn.

To be fair, we did find some local differences. For example, in New York County - better known as Manhattan - the average farmer is just north of 31. Next door in Hudson County, New Jersey, the average farmer is more than 72.

On the whole, though, America's farming workforce is getting older. If the country doesn't recruit new farmers or adapt to having fewer, older ones, it could put the nation's food supply at risk. Before panicking, though, it's worth asking: Why is this happening?

A tough field to break into

To start, there are real barriers to entry for young people at least those who weren't born into multigenerational farming families. It takes money to buy the land, equipment and other stuff you need to run a farm, and younger people have less wealth than older ones.

Young people born into family farms may have fewer opportunities to take them over due to consolidation in agriculture. And those who do have the chance may not seize it, since they often report that rural life is more challenging than living in a city or suburb.

The overall stress of the ag-

riculture industry is also a concern: Farmers are often at the mercy of weather, supply shortages, volatile markets and other factors entirely out of their con-

The ups and downs of farm life take center stage in "On the Farm," a docuseries produced by Mississippi State University.

In addition to understanding why fewer younger people want to go into agriculture, it's important to consider aging farmers' needs. Without younger people to leave the work to, farmers are left with intense labor — physically and mentally - to accomplish, on top of the ordinary challenges of aging.

In other words, the U.S. needs to increase opportunities for younger farmers while also supporting farmers as they age.

Opportunities to help

The USDA already has programs to aid new farmers, as well as farmers of color and female farmers, and those who operate small farms. Expanding these programs' reach and impact could help bring new talent into the field.

Congress could do just that when it reauthorizes the farm bill – a package of laws covering a wide range of food - and agriculture-related programs that get passed roughly every five years.

The farm bill also includes nutrition aid and funds telehealth and training and educational outreach for farmers, all of which could help meet the needs of young and aging farmers alike. Notably, the Cooperative Extension Service offers programs that range from 4-H and youth development, including introduction to agriculture, to providing on-site technical help.

Congress was supposed to reauthorize the farm bill by Sept. 30, 2023, but it missed that deadline. It now faces a new deadline of Dec. 31, but due to dysfunction in the House of Representatives, many expect the process to drag on into 2024.

Also in 2024, the USDA will release its next Census of Agriculture, giving researchers new insight into America's farming workforce. We expect it will show that the average age of U.S. farmers has reached a new all-time high.

If you believe otherwise well, we wouldn't bet the farm.

Also, present was Becky Morris Elementary Principal and Alan Hutchcraft High School Principal. The board approved the September 20th, board minutes and approved the district bills/ obligations.

Elementary Principal Becly Morris updated the Board of Education about the attendance being at 95.56% and the current enrollment PK-3-6th grade is 115 students. MDC hosted 37th annual Poosey **Conservation Area fall tour**

souri Department of Conservation (MDC) hosted the 37th annual Fall Driving Tour at the Poosey Conservation Area on Oct. 15. Cool temperatures and a light, intermittent rain early in the event failed to stop trucks, ATVs, horseback riders, golf carts, cars, and horse-drawn carriages from traversing the hilly gravel service roads. MDC crews counted 1,079 bundled up visitors at the tour's start at Pike's Lake. The moisture brightened the yellow and red colors on the autumn foliage.

MDC's Poosey fall tour allows visitors to drive vehicles on service roads normally closed to the public. Tour stops along the way highlighted conservation practices such as timber stand improvement. At a stopping point along the route, MDC and partners staffed table displays about topics such as helping grassland species, managing invasive species, and helping conservation agents with Operation Game Thief. MDC staff visited with people on the tour and answered questions.



Cameron Regional Medical Center (CRMC) announced in late August 2023 that it was terminating its contract with Ambetter's Affordable Care Act (ACA Exchange/Marketplace) product effective January 1, 2024, due to numerous concerns regarding customer services, delays and denials of care, and reimbursement that overburdened patients with costs.

Since that announcement, CRMC and Ambetter have continued discussions. As a result of those discussions, Ambetter has committed resources to address CRMC's concerns. Based on Ambetter's commitments, CRMC and Ambetter have entered a new agreement, and CRMC will remain an in-network provider for Ambetter's Affordable Care Act (ACA Exchange/Marketplace) plans through June 30, 2024. CRMC hopes that Ambetter's commitment results in resolving the issues and that CRMC and Ambetter can continue their agreement beyond June 30, 2024.

CRMC wanted to keep you apprised of this development so you knew you could continue your healthcare services here with us. We apologize for any inconvenience this uncertainty may have caused; however, we hope these recent negotiations will help improve the promptness and efficiency with which we can serve your healthcare needs.



These excursion trips were only scheduled for certain days (August 22, September 12 and October 10) of that year and people could travel to any point west of the Missouri River to see the "100-bushels-to-theacre cornfields of Nebraska and Kansas; the rich wheat lands of eastern Colorado or the wonderfully irrigated districts of northern Wyoming." Many Ridgeway residents used the cheap fares to go to visit family and friends in the west. (Ridgeway Journal, October 5, 1893)





On My Own is a hands-on,

real-life simulation that gives young people ages 13-18 the opportunity to experience adulthood in a fun and exciting way.

During the simulation, participants assume they are 26 years old, are the primary or sole support of the household, and are encouraged to make healthy and wise lifestyle choices similar to those adults face on a daily basis. After exploring careers, students receive a monthly salary for their chosen career type, a family scenario, and an asset. Then, they proceed through "real life," deducting taxes, determining a





Bethany woman charged with abusing child

A Bethany woman faces a felony charge of child abuse and neglect after allegedly hitting a boy with a cell phone and slamming his head on the floor.

Police Officer Aaron Parkhurst investigated a report from the Missouri Department of Social Services concerning the suspected abuse case involving a 12-year-old victim. A witness reported seeing a woman identified as Mary Rebecca Garton, 34, allegedly throwing a cell

phone at the victim and hitting him in the back. A second witness said that the defendant hit the victim on the head with her cell phone and heard her allegedly slam his head on the floor.

Garton was held on \$150,000 cash bond pending arraignment.

Garton was arraigned on Oct. 19 in the Associate Division of Harrison County Circuit Court. Her bond has been set at \$150,000 cash.

Missouri approves building of Grain Belt transmission line

State regulators gave final approval Thursday to the owners of the Grain Belt Express transmission line to drop off thousands of megawatts of clean power in Missouri.

The decision by the Missouri Public Service Commission was the final regulatory approval Chicago-based Invenergy needed to begin the first phase of the line, to be built in Kansas and Missouri.

For years, Invenergy has been working through regulatory approvals and acquiring land easements to build the 800-mile high-voltage transmission line, which will carry renewable energy from wind-swept western both cases, Invenergy will com-Kansas across Missouri and Illinois to the Indiana border.

"Securing the necessary state regulatory approvals is another critical step toward Grain Belt Express bringing lower electric bills and greater reliability to consumers in Missouri and across the Midwest," said Shashank Sane, executive vice president and head of transmission at Invenergy.

Grain Belt was previously envisioned as a 4,000 megawatt line that would drop off a small portion of its power in Missouri. But with Thursday's approval, Invenergy can construct a 5,000 megawatt line and drop half of its power in the state.

The line's total capacity is expected to equate to roughly four new nuclear power plants, Invenergy says.

The company plans to construct the line in phases with Kansas and Missouri first. The line, Invenergy says, will result in \$11 billion in savings over 15 years across those two states as

But the Grain Belt had to overcome strong political headwinds to reach this point. The project sparked opposition from farm groups and landowners because it will cut across private property.

Invenergy must either sign voluntary deals with landowners or use its power of eminent domain to build on the property of landowners who don't agree. In pensate property owners.

Republican legislators and agricultural groups tried repeatedly to essentially strip Grain Belt's right of eminent domain, which would have killed the project. But last year, lawmakers passed compromise legislation requiring, in the event of future large transmission lines, greater compensation for landowners and setting a seven-year time limit for companies to build transmission lines after obtaining their easements.

In a news release Thursday, Invenergy said it had acquired 95% of the easements it needs in Kansas and Missouri.

Previous versions of the legislation would have required that at least 50% of power carried by a transmission line stay in Missouri. The compromise version would require that an amount of power proportional to the length of the line through Missouri be made available to residents.

Shortly after the bill passed, Invenergy announced it would drop off more power in Missouri.

Invenergy received approval this summer from the Kansas Corporation Commission to build the project in phases.
